## Membership Categories at The Fox Hill Club

**FULL MEMBERSHIP** A Full Member is defined as a person whose age is 40 year or older. Each Full Member and their immediate family members (spouse or significant other, and children through the age of 23) may use all Club facilities, including the golf course, golf practice, tennis, swimming and social facilities of the Club. Full Members will not be required to pay green fees, court fees or pool fees for use of the golf, tennis or swimming facilities. Advance sign-up privileges for golf tee times and tennis court times will be determined by the Club from time to time.

**JUNIOR MEMBERSHIP** A Junior Member is defined as a person whose age is 39 years or younger. Each Junior Member and their immediate family members (spouse or significant other, and children through the age of 23) may use all Club facilities, including the golf course, golf practice, tennis, swimming and social facilities of the Club. Junior Members will not be required to pay green fees, court fees or pool fees for use of the golf, tennis or swimming facilities. Advance sign-up privileges for golf tee times and tennis court times will be determined by the Club from time to time.

**SENIOR MEMBERSHIP** A Senior Member is defined as a person whose age is 70 years or older. Each Senior Member and their spouse or significant other may use all Club facilities, including the golf course, golf practice, tennis, swimming and social facilities of the Club. Senior Members will not be required to pay green fees, court fees or pool fees for use of the golf, tennis or swimming facilities. Senior Members will not be restricted on tee times.

**INDIVIDUAL MEMBERSHIP** An Individual member may use all Club Facilities, including the golf, golf practice, tennis, swimming and social facilities of the Club. Individual Members will not be required to pay green fees, court fees or pool fees for use of the golf, tennis or swimming facilities. An Individual Member may be single or married. An Individual Member's spouse or significant other, and children are considered guests of the Club and must be accompanied by the member at all times.

**SEASONAL (DUAL RESIDENCY) MEMBERSHIP** A Seasonal Member is defined as a person who owns and resides at an out-of-state home for approximately six months each year. Each Seasonal Member and their immediate family members (spouse and children through the age of 23) may use all Club facilities, including the golf course, golf practice, tennis, swimming and social facilities of the Club April through September. Seasonal Members will not be required to pay green fees, court fees or pool fees for use of the golf, tennis or swimming facilities April through September. A Seasonal Member may add additional months to their membership if they wish.

**SOCIAL MEMBERSHIP** A Social Member and their immediate family members (spouse and children through the age of 23) may use the tennis, swimming and social amenities of the Club without paying additional fees. You may use the golf practice facilities at an additional fee. A Social Member may play golf as a guest of a golf member and pay the corresponding rate once per month and up to 6 times per season.

**YOUTH MEMBERSHIP** A Youth Member is defined as a son or daughter of an existing golf member who is between the age of 24 – 28. A Youth Member may use all Club facilities, including the golf course, golf practice, tennis, swimming and social facilities of the Club. Sign-up privileges for golf tee times and tennis court times will be determined by the club from time to time
